Thank you for your interest in enrolling your child(ren) at Calvary Learning Center (CLC). ***Applications will be accepted between April 1 and June 15, 2020 for the 2020-21 school year.*** Discounts are awarded according to need, the merits of each applicant, monies available, class placement, and priorities established by the Review Committee. These priorities include:

- CCA and Learning Center Staff
- Mercy Culture Church Member and Active Serve Team Members
- Full-time Military Family
- Full-time Pastor/Minister
- Single parents and/or families with limited income
- Emergency circumstances that call for temporary assistance

Discounts generally cover only a portion of the tuition cost. Parents and/or guardians are responsible for all remaining tuition and fees not covered in the award. Failure to meet the agreed upon financial responsibility may result in discontinuance of aid, up to and including termination of enrollment. Please review the Discount Criterion Attachment for more details.

For new students, a completed student application must be submitted BEFORE this discount application can be submitted; new families must go through the new enrollment process first. For returning students this application may be submitted anytime during the application window (4/1-6/15). If applying for aid for more than one student a separate application **for each child** must be completed. **Falsification of any information will disqualify the applicant from any award of benefit and may disqualify the applicant from attending CCA.**

Depending on the nature of the application, we may request sensitive financial information, including the most current federal tax returns. All information submitted is considered confidential and will be reviewed only by the Review Committee of CLC. Should the applicant family's financial status change during the period that discount aid is in effect the family is required to notify the Discount Committee of the change. **Applicants will be notified by June 30 if a discount is awarded.**
